Eastern District of Tennessee (TN-E) | Safe Harbor

\$650 CAP ON ALL PRE-CONFIRMATION FEES

Western District of Tennessee (TN-W) – Western Division | Affidavit

TN-W WESTERN DIVISION ONLY	
Do Not File PPFNs for the Following	
1. Plan Review	
2. 410 Prep/File	
3. 410A Prep/File	
4. Objection to Plan Confirmation (OTP)	
If PLG has received a PPFN referral for Bankruptcy Attorney’s fees in this division, PLG will place on hold; unless specific direction from the Creditor is received otherwise.	
Failure to Comply: Will Result in Objection to PPFN	
<i>This hold is temporary as the legal community continues to work to have the newly established affidavit requirement retracted. However, at this time, TN-W (Western Division) should be treated similarly to PA-W (no PPFNs for attorney’s fees). **In the event a Creditor would like to file a PPFN for an amount under the safe harbor of \$500, with acknowledgement of preceding litigation, please advise PLG so litigation strategy can be discussed.</i>	



Middle District of Florida (FL-M) – Jacksonville Division | Safe Harbor

\$865 CAP ON ALL PRE-CONFIRMATION FEES	
PPFNs for bankruptcy attorney fees cannot exceed \$865	
<u>INCLUDES</u>	<u>DOES NOT INCLUDE</u>
