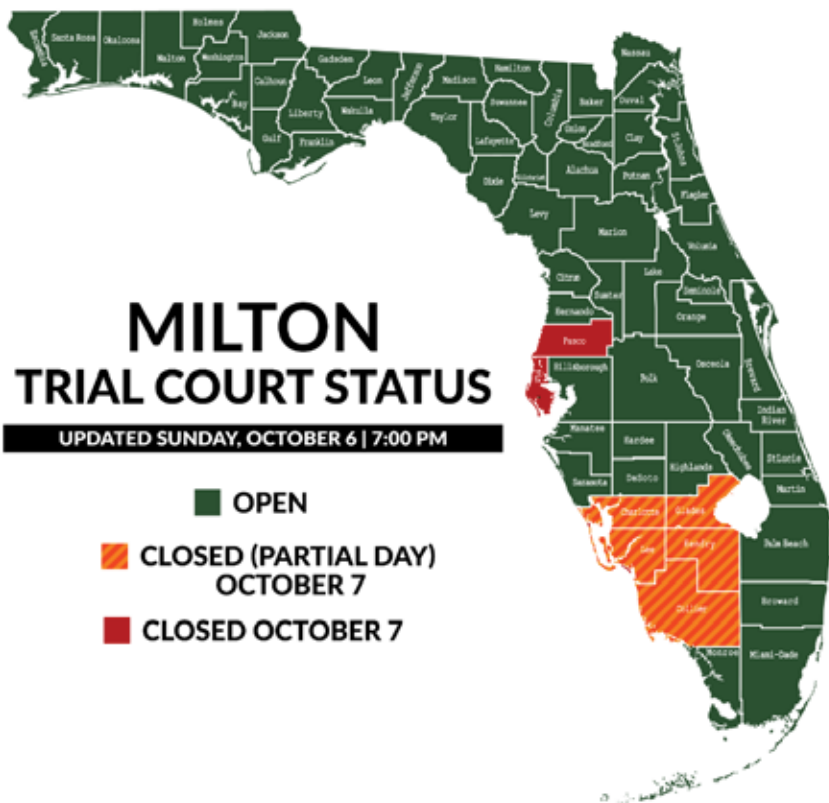


Dear Valued Client:
